Thank you for your Freedom of Information request submitted via email to Criminal Justice Inspection Northern Ireland on 08 July 2009 in accordance with Section 8 of the Freedom of Information Act 2000.

Our understanding of the information requested in relation to the period 1 January 2008-present day (i.e. date the request was received - 08 July 2009) is as follows:

- a list of public figures which this organisation has paid to carry out public presentation/campaigning/networking or publicity in accordance with the definition stated in the original request for information on its behalf;
- the identity of the individual/s, an outline of the work undertaken and the date, venue, location; and if appropriate, the title and copies of any printed, visual, photographic material or commercial presentation; and
- the amount paid to the individual/their agent or company for their input.

In response to your request for information, I can inform you that the following information is being released and details are below.

Queries 1 and 2

From 1 January 2008 – 8 July 2009 this organisation paid two individuals for their involvement in two conferences.
