





INSPECTION OF MAGHABERRY PRISON 2022

In September and October 2022 there was an inspection of Maghaberry Prison. This booklet tells you what Inspectors found. A copy of the full report is in the library for you to look at.









WHAT IS A PRISON INSPECTION?

A prison inspection checks out how well services are working and what needs to be better. In this inspection we wanted to see how well people living in Maghaberry Prison were being treated and cared for.

When we inspect prisons, we look at five areas:



Leadership



Safety

how safely you are held.



Respect

you are treated with respect.



Purposeful activity

you can take part in learning, work and activities.



Rehabilitation and release planning

you can keep in touch with family and friends, get help to stop offending and after what will happen when you are released.



WHO DID THE INSPECTION?

The Inspection Team was made up of people from four organisations who looked at the prison, health care and education services.



All prisons in Northern Ireland and across England and Wales are rated the same way. Inspectors look at all the evidence and decide how well the prison is doing on safety, respect, purposeful activity and rehabilitation and release planning.

There are four ratings:



Good

In these areas things are working well for prisoners.



Reasonably good

Things are mostly working well but some things need to improve.



Not sufficiently good

Things are not working well.
If nothing is done, these areas will become serious concerns.



Poor

Something needs to be done immediately.

WHAT YOU TOLD US WHEN WE WERE AT MAGHABERRY

This is what people who were in Maghaberry Prison when we did the inspection told us.



said the overall quality of health services was very/quite good



said they had been helped with their mental health problem



50 %

said they spent less than two hours out of their cell on a typical weekday reported completing offending behaviour programmes



said they felt safe



said most staff treat you with respect



said it was easy for their family to visit



indicated it was very/quite easy to get illicit drugs

Unless otherwise stated the survey findings relate to the main prison site and exclude the Mourne complex.
